## MOTION TO EXTEND RESPONSE TIME TO MOTION FOR DISMISSAL OR ALTERNATIVELY FOR A NEW HEARING

Navah C. Spero, Esq., Special Assigned Disciplinary Counsel ("<u>Special Disciplinary</u> <u>Counsel</u>"), respectfully requests to extend the response time to reply to Respondent's Motion for Dismissal or Alternatively for a New Hearing ("<u>Motion to Dismiss or New Hearing</u>"), filed July 24, 2023. In support, Special Disciplinary Counsel advises as follows:

Special Disciplinary Counsel seeks an eleven day extension of time to respond to the Motion to Dismiss or New Hearing. Respondent does not cite to any rules authorizing the filing, and therefore it is not clear precisely what the response deadline is. However, Special Disciplinary Counsel has assumed the 14-day deadline in V.R.C.P. 7 applies, making the response deadline August 7. As a result of her schedule, Special Disciplinary Counsel has limited time to effectively respond by the August 7 deadline. Between July 24 and August 7, Special Disciplinary Counsel's schedule includes taking several party depositions and an all-day, on-site inspection.
